Report to the board of directors October 9, 2013

Enrollment

We currently have 188 students enrolled. We should have two additional students between October and January (MS and CP)

Academic life

Teachers have been working on aligning our report cards with our written curriculum. The updated report cards will be ready for December.

Cedric and CB have been developing Mid-year and End of the year Mathematics assessments for students in 4th and 5th grade. These tests, based on our curriculum and using different formats (timed MCQ 'ERB-like', a comprehensive balanced assessment, and a more challenging open-ended problem), will allow us to provide opportunities to students to train to take timed-tests, provide a comprehensive and detailed picture of student achievement in Mathematics for parents and will provide the school the necessary data to review and update our teaching.

Students are also tested in reading in K and 1st grade under the same general principles. Results are shared with parents during parent-teacher conferences.

Teresa and Fabrice are working on the beginning of the individual linguistic e-portfolio which will allow students, parents and faculty alike to monitor long-term progress in oral language in their non-native languages. The tasks supporting the portfolios are aligned with our expectations in language for non-native speakers as specified in our curriculum brochure.

These three different projects complete the virtuous circle of triple alignment i.e. written curriculum, delivered curriculum and assessed curriculum are aligned to form a coherent ensemble that is completely transparent to all the stakeholders.

Cedric will begin working on alignment on our Science curriculum with the Next Generation Science standards in November for a June 2013 completion date; that will lead to a version 2.0 of our curriculum brochure.

Professional development

In Partnership with the French Embassy in Washington DC, the school will welcome Professor Pierre Escude for a conference on "intercomprehension of romance languages" on Thursday October 26th at 6:30pm in the auditorium. Pierre Escude developed a new approach for teaching languages based on what languages such as English, Spanish and French have in common. Philosophically, this approach is closed to AIS teaching paradigm: One Curriculum, Three Languages. Three languages, One class.

The school will welcome <u>Vincent Gerard from Bordeaux during the week of Oct 28</u>, Vincent will work with CP-Ce1 teachers and with Cedric to develop a scope and sequence aligned with NGSS and that is coherent with children cognitive development. Vincent will also help Cedric with the design of our Science Night that will be held on....

On March 20-21, Julie Higounet from the French Ministry of Education will come to work with teachers and Fabrice on the topic "Integration of Technology and differentiation".

On March 26-28, the new pedagogical coordinator based in San Francisco, will visit the school and work with maternelle teachers on a topic to be identified.

Technology

Thanks to Janet Shotwell, the school recently received 8 projectors (4 have been installed in K and 1st grade classrooms, one being installed in the Science room, the rest being shared in the school).

As of today, each class from CE1-CM2 has one computer or tablet for every three students giving teachers the resources to better integrate (in a productive mode) the technology to their curriculum. Each class from CP to CM2 has a smart board.

Next step will probably be to equip K and CP classes with tablets.

The new fiber optic internet connection is scheduled to be running by October. This will allow students and teachers to have access to and to produce meaningful content (AIS academy project)

Website update

Suzanne is working on an update of our website that will be more interactive and more user-friendly with much more pictures and videos for parents and visitors to feel more connected with our community. It will also tell AIS story in more consistent way, using a more impactful lexicon.

A landing page for our prospective parents will create a virtual community for them allowing us to welcome them in our community even before they enroll.

The completion date is October 31st. Feedback on how to improve it will be, as always, welcome.

Development

Annual fund

We raised \$14,805 (37% of our \$40,000 goal)

Participation is 25% for parents; Staff is 72%; board is 71%

Kyle is working on the Fun(d)Run and on the Gala preparation. She is also reaching out to program officers to submit grant proposal. More details in November.

Marketing and admissions

We have our first Open House on Saturday November 16th. We have revisited the organization of the day and reshape our message based on the work we have done with STEEL.

The updated website will become the platform for prospective parents to engage with AIS community.

We will placed ads from Oct 28 to Nov 16 on KUT and KLRU and we have a full page on the Relocation Guide that will be published in December and June (and a presence on their website as well).
